

**ADOPTED 2018 TARIFF SCHEDULE FOR BELLINGHAM INTERNATIONAL AIRPORT**

<u><b>DESCRIPTION OF FEES</b></u>	
<b>Ground Service Fees</b>	
• <b>Parking (daily rates)</b>	First 30 minutes free \$1.00/hour (after 30 min.) All parking minimum \$6/day — maximum \$18/day, prices subject to market conditions and Executive Director approval (No weekly rates)
• <b>Lost Parking Ticket</b> (Minimum fee)	Lost ticket Minimum fee = Lot daily maximum
• <b>Airport Employee/Company Parking Permits</b> All Airline, GA, TSA, and non-concession tenants	\$80.00 annually or \$20.00 per month
• <b>Lost RFID Parking Pass</b>	\$25 replacement/penalty fee for lost employee/company RFID parking pass
• <b>Promotional Programs / Rate Adjustments</b>	The Executive Director may respond to changing market conditions by offering discount coupons, parking promotional opportunities and parking rate adjustments.
• <b>Premium Reserved Parking</b>	Online service fee up to a maximum of \$5 per reservation (prepaid) In addition to the daily rate, plus a surcharge for premium parking is set by the Executive Director based on market conditions.
• <b>License to Operate Fees</b>	
o Courtesy Shuttle Operators	\$60/month
o Taxi Cab Operators	\$30/month fee plus 3% on monthly sales over \$750
o Limousine Operators	\$125/annual fee plus 3% on monthly sales over \$750
o For Hire Shuttle/Bus Operators	\$35/month fee plus 3% on monthly sales over \$750
o Offsite Airport Parking Lot Shuttle Operators	\$125/month fee
o Transportation Network Company (TNC)	\$2.00 per trip for passenger drop off and \$2.00 per trip for passenger pick up
Ground Transportation Service Operator (GTSO) Requirements Fine	\$100 per violation

Commercial Scheduled and Unscheduled	\$1.38 per 1,000 lbs. of landed weight
Non-hangared (Itinerant) GA aircraft over 7,500 lbs. (gross wt.) All commercial/cargo flights (minimum charge of \$50.00)	\$1.15 per 1,000 lbs. of landed weight
• <b>Fuel Flowage</b>	
Applies to aircraft fuel transported onto airport property	\$.09/gallon (General Aviation Only) \$.04/gallon (Commercial Airlines into plane only)
• <b>Aircraft Rescue and Fire Fighting (ARFF)</b>	\$275 per landing (only charged to non-signatory carriers)
• <b>Based Aircraft Remain Overnight (RON) Parking</b>	\$40.00/night
• <b>Transient Tie-Down</b>	
Single Engine	\$11.00/day           minimum billing fee of \$40.00
Twin Engine	\$22.00/day           minimum billing fee of \$40.00
Jets	\$44.00/day           minimum billing fee of \$40.00
• <b>Air Taxi</b>	\$230 annual fee plus landing fees
• <b>Non flyable/Derelict Aircraft Fine</b>	\$10.00/day for 60 days from date of notice until removed, w/ removal at owner's expense after 60 days

• <b>Business License</b>	\$125 annual fee
• <b>Security Access Card</b>	
General Aviation (Non-SIDA)	\$30.00 per application after tax \$32.55
Commercial (SIDA)	\$60.00 per application after tax \$65.10
Lost (individual) or unreturned (employer) (after 90 days)	\$100.00 per card
Reprint (damaged/faded/lost)	\$20.00 per card after tax \$21.70
Renewal (within 30 days of expiration)	\$40.00 per SIDA application with fingerprinting services after tax \$43.40 \$20.00 per non-SIDA application or SIDA application without fingerprinting services after tax \$21.70
• <b>Security/Safety Violation</b>	\$50.00 2nd Violation \$100.00 3rd Violation
• <b>Fingerprinting (no badge issued)</b>	\$35.00 per occurrence after tax 37.98
