Blaine Webhouse No. 1 and Milhollin Ave Water Main Replacement

RMC Architects, Inc. (RMC); Professional Services Agreement Amendment No. 3

ACTION REQUESTED

Authorize the Executive Director to execute Amendment No. 3 to the Professional Services Agreement with RMC Architects for the next phase of design and permitting assistance for the Blaine Webhouse No. 1 project in the amount of \$17,500 plus a 10% contingency for a total contract amount of \$346,618.50.

BACKGROUND

RMC was hired in March 2018 to provide design, permitting, and cost estimating assistance for the Walsh Marine Building, Blaine Webhouse No. 1, and the stormwater system upgrades at Blaine Webhouses 2 and 3. In November 2018, the Commission approved a Developer Extension Agreement with the City of Blaine to replace the existing Asbestos Cement water main along Milhollin Ave as part of the Blaine Webhouse No. 1 project. As described in the attached proposal, PSA Amendment No. 3 would allow RMC to update the Webhouse No. 1 permit applications and bid package to include this watermain replacement and any other necessary revisions.

FISCAL IMPACT

PSA Amendment No. 3 will be fully funded by Capital Improvement Projects 216-776-1900 and 220-892-1900, which have a combined budget of \$4,126,000

PURPOSE

These projects contribute to the following 2019 Key Corporate Goals:

- No. 3 Expansion of Marine Trades
- No. 6 Stimulate Economic Development and Job Creation
